Meeting called to order at 5:31 pm Quorum was confirmed.

SECRETARY'S REPORT:

Presented meeting minutes from the PTO General meeting on February 28, 2019. No changes or corrections were noted. Minutes accepted as presented.

PRINCIPAL'S REPORT (Ms. Honore):

The school has started locking all doors on campus. This is an added measure of security for students and staff.

We received our CleverTouch boards today, which is new technology purchased from Spring Auction funds. Sixteen teachers will be able to use them.

There are still tickets available for the Dynamo game on May 4. So far, 120 tickets have been purchased.

Houston ISD announced that is it will not cut PUA from school budgets for the 2019-20 school year.

Houston ISD also approved seven new teacher/staff positions for our school! Our goal is to reduce class size and this is a huge step in the right direction! We are doing our due diligence to ensure that these positions will be filled with caring and sharp individuals who have the best interest of our Panthers at heart!

PRESIDENT'S REPORT (Amy Maddux):

Welcome and sign in.

The last general meeting of the year will be held on May 23 in the morning. We will vote on the PTO 2019-20 budget. After we adjourn everyone is invited to attend "Coffee with the Principal."

Friday (April 26) is the final day to fill out the PTO's online survey. We are fortunate to have more funds available than previous years and welcome feedback and guidance from parents, teachers and staff on how to program those funds.

Amy called for nominations to the board from the floor. None were put forth. She then called for a motion and second to vote of the membership on the proposed slate of nominees for the 2019-20 PTO board:

The vote was approved by the PTO board and membership.

Amy explained the proposal to amend the PTO bylaws to allow delegation of treasurer duties so that the treasurer can be assisted by the assistant treasurer. The amended section(s) includes: **3.05. Duties**

Treasurer:

Serve as custodian of the PTO's finances, collect revenue, pay authorized expenses, issue tax receipts for donations received, report financial activity every month, prepare year-end financial report, facilitate an annual reconciliation committee, be authorized to sign on bank accounts, and hold all financial records. The treasurer may delegate a portion of these responsibilities, including its authority to sign on bank accounts, to the assistant treasurer, who will be appointed by the treasurer.

6.02. Banking

All funds shall be kept in a checking account in the name of Frank Black Middle School PTO, requiring two signatures of the Executive Board and held at a local financial institution. Signers of the bank account shall not be related by blood or marriage and shall not reside in the same household.

Signers on the account are President, Treasurer, Vice President of Education, Vice President of Fundraising and the Vice President of Community Building. Provided the Treasurer has delegated his/her authority, the Assistant Treasurer is authorized to sign in place of the Treasurer and such signature shall suffice as one of the two required Executive Board signatures. The Secretary of the PTO shall not be a signer. An association member shall not sign a check if they have a direct or indirect interest in the expenditure.

She then called for a motion and second to amend the bylaws as written above. The board and membership approved the motion.

A new position has been added to the board roster. The Sponsorships chairperson will be in charge of cultivating a database of contacts and for coordinating sponsorship activities related to PTO fundraisers.
